

## Presentation Styles

with James King and Kathy Notter

Describe and discuss leadership styles, including Situational Leadership, Leader-Member Exchange, Transformational Leadership, and Servant Leadership. Examine leadership and follower roles, outcomes, and individual levels of service.

It has been the focus of past leaders to continually be the “boss” in which they provide all the answers both good and bad, whether they know “it” or not. New research suggests the need to rethink our view of leadership and leaders and what leadership means to our organizations. What are the roles of leadership? What are the implications for followers? What are the expected outcomes for each style of leadership? Finally, what is the impact of each style of leadership on the individual, interpersonal, group, organizational, and societal level?

Leadership affects everyone. For better or worse, poor leadership is easy to detect. What are some new and emerging, research-based leadership models that have the ability to resolve leadership problems? Ideas will be given for leadership training, in particular mentoring and coaching. Ensuring good leaders are in positions of most effectiveness ensures growth and viability in any organization.
