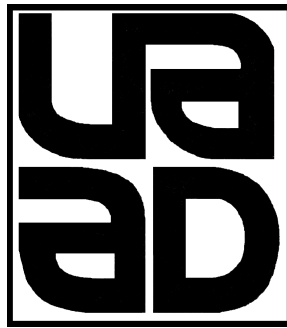

December meeting features baseball coach Van Horn

Baseball may not be the first thing that comes to mind in December, but believe it or not, college baseball is just around the corner.

Coach Dave Van Horn will be speak at the Dec. 19 meeting and provide a look back at the 2001 Nebraska Baseball season (the most successful and exciting ever) and a look ahead into 2002 (the first time in the new stadium).

Van Horn, who was hired in January 1998, has guided Nebraska Baseball from the depths of the conference standings before his arrival to its best two seasons in the 112-year history.

In 2001, the Huskers claimed the first College World Series berth in school history

with their first NCAA Super Regional title and second straight NCAA Regional crown.

The Huskers also captured their first regular-season conference crown since 1950 and their third consecutive Big 12 Tournament title. This made them the first team to win Big 12 regular-season and tournament titles in the same season.

To top off the season, Van Horn earned Big 12 Conference Coach-of-the-

Year honors and was selected NCAA Coach-of-the-Year by Baseball America. Four of his players earned first-team All-America recognition by at least one publication, and two players earned Verizon/CoSIDA Academic All-America recognition.

UAAD invites you to recognize those deserving colleagues who give of themselves to make this University a better place to work. Two awards are presented each February at the Founders' Day celebration.

They are the Carl A. Donaldson Award for Excellence in Management and the Floyd S. Oldt Award for Exceptional Service and Dedication to UNL.

The Carl A. Donaldson Award was created to recognize individuals who have demonstrated outstanding management skills. The award, which has been given annually since 1972, is named after the founder of UAAD. Mr. Donaldson devoted 43 years to University service and made significant contributions to the growth and development of the University of Nebraska. Any UAAD member or other full-time UNL

employee with management responsibilities is eligible for the award.

The Floyd S. Oldt Award was created in 1992 from a substantial bequest from a life insurance trust, established by Floyd S. Oldt. Mr. Oldt was a member of the University of Nebraska class of 1920 and a prominent general contractor in Texas. The major criteria for the Floyd S. Oldt Award will be incidents or examples illustrating the nominee's exceptional service and dedication to UNL. Any UNL managerial/ professional staff member will be eligible for this award.

UAAD General Membership Meeting

Wednesday, November 14, 2001

President Jim Main called the UAAD General Membership meeting to order at 11:58 a.m.

Approval of Minutes: Minutes from the October 17, 2001 General Membership meeting were approved as written.

President's Report - Jim Main: Jim invited members to introduce guests and new members in attendance.

Committee and Officer Reports:

Employee Liaison-Cindy Bell: Cindy has the first draft of the analysis of the UAAD survey. The first section was developed to analyze the importance of what brought employees to UNL and also the employees' satisfaction with those same factors now. The analysis is done by gender, salary range, length of service, and reporting unit. Items were ranked on a scale from 1 to 5. There were 11 factors rated highly important, led by retirement, vacation time and type of work. The survey indicated there is a great deal of disparity between salary/wages and career advancement opportunities. A verbal analysis will be put on the web page when it is complete. Jim Main plans to relay all information gleaned from the survey to the campus administration.

Membership-Nancy Pittman: Nancy introduced the following new members: Allen Behne, Purchasing; Allan Henrichs, Shared Computing Services; Jeff R. Wilson, Engineering Extension; Patricia Christen, Physics & Astronomy; Deana Unger, Scholarships & Financial Aid; Mike Cacak, Transportation; Kim Sabatka, CBA; Yoko Smith, Environmental Health and Safety; and Brenda Osthus, Environmental Health and Safety. We have 200 UAAD members to date.

Alumni Association Membership Presentation: Duane Mohlman presented Connie Walter with this month's complementary annual membership to the Alumni Association for her efforts in new member recruitment.

Professional Development: Jim announced for Vicki Highstreet that Dr. Richard Collins, the "Cooking Cardiologist," will be on campus on December 7 from 11:00 to 1:00 at the Nebraska Center on East Campus. He will not only cook for us, but he will share important messages about healthy eating.

Program - Pam Murray: Pam announced that next month's general meeting will be the "Graze and Mingle" meeting on Wednesday, December 19 at 11:45 at the Culture Center, 333 N. 14th. This is a potluck, so bring a dish to share. The speaker is Nebraska baseball coach

Awards - Rachelle Setsodi: Rachelle encouraged everyone to nominate a colleague for the Oldt or Donaldson award. The deadline is Jan. 11, but the committee would appreciate getting nominations in December so they have time to collect all of the application materials and letters of support.

Treasurer's Report - Mike Carlson: The UAAD Foundation account balance is \$1,310. The UAAD checking account balance is \$2,704.96. We currently have a balance in our Cost Center Account of \$454.88. Thanks to VCBF Christine Jackson for her office's donation of \$500 to our account for professional development purposes.

Old Business: Duane Mohlman currently is reviewing the membership approval process. The Executive Board will look at this issue and should have something for the general membership to vote on at the next general meeting.

New Business: Chat with the Chancellor is set for Nov. 28. Immediately after that, a discussion will be held concerning pooling salary dollars of managerial/professional and office/service staff.

Speaker Introduction: Pat Gergen introduced Tom Huston, an attorney and partner with Cline, Williams, Wright, Johnson and Oldfather and adjunct faculty with the Department of Community and Regional Planning, Wynn Hjermstad, manager of the Community Development Division in the City of Lincoln Urban Development Department, and Doug Beals, Facilities Planner with the Department of Facilities Management & Planning at UNL.

Speakers: The Antelope Valley Project likely will be the largest public infrastructure project for the city of Lincoln during our lifetime. This project involves a three-way partnership between the city of Lincoln, the University of Nebraska and the Lower Platte South Natural Resources District. This project is trying to address three needs: The flood plain problem in the core of the city, the traffic problems in downtown Lincoln and the need to revitalize downtown Lincoln. The project will affect the entire city of Lincoln as it attempts to stop flight from the city center so deterioration doesn't occur.

The major components of the Antelope Valley Project are the Antelope Creek improvement (flood control), major street improvements, and the city's community revitalization projects. This is a 20-year project. The first phase will take 5-7 years and will benefit the UNL camps by diverting through-traffic around the campus, eliminating hazardous railroad crossings, completing the campus perimeter roadway system, supporting the campus master plan and removing the flood plain from campus. It will displace four buildings (Inventory Building, Auto Body Shop, Texaco South Building and Transportation Services Building) and some recreation fields. A total of 1400 surface parking spots also will be displaced; the proposed parking garage at 14th & Avery will help with the loss of these parking spots if it is constructed. New recreation fields are planned for a new park at 33rd and Huntington Streets.

It is anticipated that construction will begin in October, 2002. The Joint Antelope Valley Authority is in charge of implementing this \$200 million project.

No one is certain how the current budget reduction may impact this project.

President's Report: University administration is looking for quick fixes to handle the budget reduction, but more permanent solutions will be needed by July 1, 2002. By Dec. 1 Chancellor Perlman hopes to have a game plan to the campus community regarding how UNL will handle the reduction.

The meeting was adjourned at 1:12 p.m.
