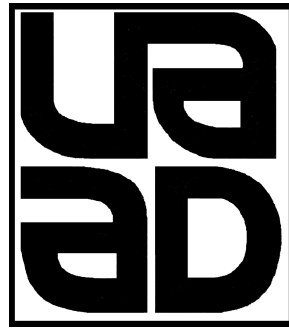

Happy Spring to everyone! It was great having such nice weather — I know it made me feel better. What doesn't make us feel any better is a spring filled with yet another round of budget cuts. March 10, Chancellor Perlman announced one-third of the potential cuts that could occur for 2003-2005. At this point 20 managerial/professional staff members have been slated for cuts. Members of the UAAD Executive Board spoke to the Academic Planning Committee March 12 to provide them with viewpoints of managerial/professional staff. UAAD routinely is asked to provide input on the budget situation, as well as other issues that are of importance to the University family. With that in mind, I encourage you to contact us with your opinions about issues of importance to you. Our emails are elsewhere in the UPDATE and elsewhere on the UAAD web site.

A member of UAAD also will be a representative to the newly formed Faculty and Staff Budget Reduction Impact Fund Awards Committee. This fund was created by Chancellor Perlman and is at the University of Nebraska Foundation. It will assist faculty and staff who are adversely affected by the budget reductions. Chancellor and Mrs. Perlman made the initial contribution of \$10,000 to start the fund and recipients are determined by the Awards Committee. When the Committee deems the fund is no longer necessary for the purposes for which it was formed, any remaining funds will be deposited into the UNL Employee Emergency Loan Fund. President Julie Hagemeyer called the meeting to order at 12:11 p.m. after lunch was served.

Approval of Minutes: Minutes from the January 14 general membership meeting were approved as written.

Russell thanked the members of the Awards Committee for their work - Rosalee Swartz, Sally Buchholz, Jesse Hock and Kristin Steffen (the off-campus representative.) He then thanked all the nominators and references who provided information on the nominees, adding that it was rewarding to read wonderful things about them all. He remarked on the service, dedication and commitment of all involved. He also recognized former winners who were in attendance.

Julie introduced Chancellor Perlman.

Chancellor Perlman thanked everyone who works at UNL, saying he was delighted to participate in this recognition and celebration of success. He read the description of the Donaldson Award and announced the winner - Tad McDowell, Director of Parking and Transit Services. McDowell thanked his staff, saying that it's the people at UNL that make the job worthwhile. Chancellor Perlman read the description of the Oldt Award and announced the winner as Bill Bode, Director of Purchasing, Inventory and Material Management. Chancellor Perlman then recognized the other nominees - J. Michael Cacak and Mick Reynolds.

Resolution Memorandum

To: Members of the Appropriations Committee, Nebraska Unicameral

Date: March 4, 2003

Subject: A Resolution concerning the funding of the University of Nebraska

The University Association for Administrative Development (UAAD)

UAAD is an organization comprised of 201 managerial/professional employees of the University of Nebraska-Lincoln (UNL). Our members come from over 100 different UNL units or departments, and from both Lincoln campuses. UAAD's goals are to:

1. Stimulate the improvement of operations in administrative and managerial areas of the UNL,
2. Promote professional development among participating members through the exchange of ideas and techniques, and
3. Provide a vehicle of communication between UNL / NU administration and the UNL administrative and managerial/professional staff.

In addition, UAAD is frequently called upon by the chancellor and vice chancellors to provide input on issues affecting university employees and to provide representatives to serve on campus committees. Also, the concerns of administrative and managerial / professional employees are addressed by the organization and brought to the membership. The position of the organization is established and communicated to campus administrators and other appropriate individuals.

Background of this Resolution:

During the monthly UAAD general membership meeting on Wednesday, February 19, 2003, the UAAD membership brought forth and unanimously passed a motion to empower the UAAD Executive Board to compose a resolution concerning the University of Nebraska budget situation. On March 4, 2003, the UAAD Executive Board wrote and unanimously passed said resolution. The resolution appears on page two of this document.

Resolution

March 4, 2003

Whereas, The University of Nebraska (NU) has already absorbed three recent rounds of significant and painful budget cuts; and

Whereas, The mission of a state-supported land grant university is to provide a quality education to the state's citizens, and at a reasonable cost; and

Whereas, Cuts of this magnitude will force tuition rates to the point where many of our state's citizens will be denied an education, or forced to go somewhere else; and

Whereas, Cuts of this magnitude will reduce and/or eliminate many important programs and services; and

Whereas, Cuts of this magnitude will have significant negative impacts on current NU students and prospective students, including financial harm and decreased undergraduate and graduate program choices and/or course offerings; and

Whereas, A strong NU is necessary to the state's short- and long-term economic recovery and future prosperity; and

Whereas, It would take years to recover from such a massive budget cut, and would eliminate the progress that has recently been made; and

Whereas, That due to the three recent rounds of NU budget cuts, our members' morale is low; our members' workloads have increased due to significant numbers of lost positions; and our members' have little hope of any meaningful salary increases, at least in the near future.

Resolved, Based upon the facts presented here, the 201 members of the University Association for Administrative Development, University of Nebraska-Lincoln, respectfully request that members of the Appropriations Committee of the Nebraska Unicameral continue to oppose any additional significant and/or unfairly proportioned budget reductions to the University of Nebraska. Unanimously passed and signed by the UAAD Executive Board, March 4, 2003, on behalf of the 201 members of UAAD.
