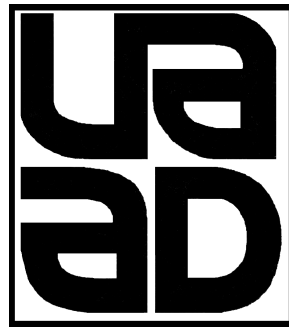

LIFE workshop focuses on elder caregiving

The University Association for Administrative Development invites all managerial/professional staff to a LIFE (Lincoln Information for the Elderly) workshop with Donna Washburn, Paul Yates, and Houston Doan on Wed., Nov. 7, from 11 a.m. to 1 p.m. at the East Campus Union.

"Few people consider themselves caregivers and few know it is a sign of strength to ask for help when they find themselves in that role," Washburn said. "There is support to help elder caregivers balance their lives, and community resources that help older persons stay in their own homes longer." At the workshop, participants can find out how easily burnout can occur, as well as answers to the financial and legal concerns involved with elder caregiving, she said.

Washburn, a UNL graduate, has been a professional caregiver for 8 1/2 years. She is a past case manager for the LIFE office in eight counties. Currently, Washburn coordinates the ElderCare portion of the Nebraska Caregiver Website, Lincoln's Caregiver Support Group and the ElderCare Connection.

Paul Yates has been with the Area Agency on Aging for 19 years. He has a Bachelor's degree in social work with a specialization in gerontology from UNO. He has been a LIFE Counselor and Director of Senior Employment - Operation ABLE, and currently is the Director of Development for the Senior Foundation for the Area Agency on Aging.

Houston Doan is a UNL graduate and has been an insurance representative and independent broker who focuses on estate planning. He is a counselor for ABLE and a financial/insurance advisor for the LIFE office where he assists the older population with questions about Medicare, insurance, estate planning and other financial matters.

UAAD General Membership Meeting

Wednesday, September 19, 2001 – Wick Alumni Center

President Jim Main called the UAAD General Membership meeting to order at 11:57 a.m. After welcoming the group and introducing current officers and former Presidents, minutes from the May 16 meeting were approved as written. A moment of silence was observed for the victims and those touched by the tragic events in New York City, Washington, D.C., and Pennsylvania this past week.

President's Report–Jim Main:

Jim and UNOPA President, Pat Hust, attend monthly meetings with the Chancellor. In the two meetings this year, there have been discussions of potential budget reductions. UAAD members were encouraged to contact the Legislature about tremendous impact significant budget reductions will have at UNL. We know we will get an adjustment, but we don't want to absorb all of the cuts. In the year ahead, Jim anticipates UAAD will be asked to contribute thoughts and opinions on the budget reduction and other issues. Jim said his personal goal for the year is to increase membership in UAAD. Currently there are about 1,500 managerial/professional staff members on campus; approximately 200 members. UAAD will do more membership promotions, but each member is encouraged to recruit at least one person.

A comment was made that we should change the bylaws so potential members do not need to apply and be voted in by the Executive Board. The concern is that this may be seen as elitist and may prevent potential members from joining. Jim will have the Executive Board discuss this at the next board meeting.

Committee and Officer Reports:

Employee Liaison–Cindy Bell: The Employee Liaison Committee surveyed all managerial/professional staff last year. The results of that survey are being analyzed and Cindy will provide information as it becomes available. The Chancellor's Office is working on a survey of campus climate. They have asked for UAAD's survey results as they create their own.

Membership–Nancy Pittman: Seven new members were introduced: Cathy Jewell from Campus Recreation, Tari Hendrickson-Sweeney from Academic Affairs, Lana Johnson from Communications & Information Technology, Kay Kottas from Landscape Services, Ron Burke from Housing, Tony Hernbloom from Campus Recreation, and Heidi Menard from Facilities Planning/Construction.

Jim said he will announce a contest at the Deans' and Directors' meeting this fall. He will keep track of how many new UAAD members each Dean or Director has then take the Dean or Director with the most new members for the year out to lunch.

Professional Development–Vicki Highstreet: Dr. Richard Collins, the "Cooking Cardiologist," will be on campus Dec. 7. He will cook and share important messages about healthy eating.

Programs–Pam Murray: UAAD travel mugs are \$5 and will be available at selected monthly meetings. IANR Vice Chancellor John Owens will speak at the Oct. 17 meeting, which will be in the City Union. Future meetings include: November–Tom Williams (attorney, Antelope Valley Project, East Union); December–Dave VanHorn (Baseball Coach, venue TBA); January (joint meeting with UNOPA)–John Cook (Volleyball Coach, East Union); February–Chancellor Perlman (Founders Day, City Union); March–Gordy Karels (JD Edwards Honors Program, Kauffman Center); April–Vice Chancellor for Research Prem Paul (City Union); May–Gary Moulton (Center for

Great Plains Studies), Reece Summers (Great Plains Art Collection) and possibly someone from the Lentz Center (Hewitt Place).

Publicity/Public Relations: Jim Main announced in Connie Walter's absence that we will try to get the Update out sooner in coming months.

Treasurer's Report–Mike Carlson: The UAAD Foundation account balance is \$1,280.00. The UAAD checking account balance is \$2,218.15. We currently have a balance in our Cost Center Account of \$494.50. Last year's books are currently being audited. The UAAD budget will be completed by next month's meeting.

New Business: UAAD's Chat with the Chancellor will be held at noon Nov. 27 in the City Union. Rachele Setsodi has been working on behalf of UAAD to invite Vice President Cheney to speak on the UNL campus this spring. In conjunction with the Chancellor's Office, a commitment from him to come to campus had been secured prior to last week's events. We are still hopeful he will be able to come, but things are up in the air at this point. We will keep you posted.

Guests: At this point members were asked to introduce any guests in attendance.

Speaker Introduction–Duane Mohlman: Duane explained that while he was President of UAAD, he found that UAAD and the Alumni Association share many similar interests. Roughly 60% of UAAD members have a degree from UNL and spend a good portion of time here. So, he began to explore partnerships between UAAD and the Alumni Association. He thanked Marc Schkolnick, Associate Executive Director of the Alumni Association, for being with us today.

Program–Marc Schkolnick: Marc extended regrets from Ed Paquette, who couldn't attend the meeting because he was at a funeral. Marc said a primary goal of the Alumni Association is to become more visible on campus. Membership in the association is open to friends and supporters of UNL, not only alumni. So, all UAAD members are welcome to join. As part of the new partnership between UAAD and the Alumni Association, UAAD will receive one free annual membership per month to give to a member who has excelled in recruiting. The first free annual membership was given to Vicki Highstreet.

Marc also talked about the mission and goals of the Alumni Association. The mission is to facilitate the relationship between alumni and friends and the university, and between alumni and friends and each other. The hope is to become the No. 1 alumni association in the country.

There are three divisions within the Alumni Association: Communications, Programming, and Business. Mark then outlined their five areas of focus:

- To support, serve and advance the mission and outreach of UNL.
- To Support and serve current students–our future alumni.
- To Develop and maintain campus traditions.
- To support and provide service to alumni and friends.
- To attract new alumni and friends to become members.

The meeting was adjourned at 1 p.m.

Vice President John Owens to speak at meeting

John Owens, Vice President of the University of Nebraska and Vice Chancellor for Agriculture and Natural Resources, will speak on "The Land-Grant University Movement and the Future of IANR" at the Oct. 17 UAAD meeting. Owens, who assumed his post in January, is responsible for providing leadership for all agricultural and natural resource activities within the University as they involve the office of the Chancellor of UNL and the President and Board of Regents of the University of Nebraska.

Prior to coming to Nebraska, Owens was the Executive Vice President and Chief

Academic Officer of New Mexico State University. He previously had served as Dean and Chief Administrative Officer of the College of Agriculture and Home Economics, the New Mexico Agricultural Experiment Station and the New Mexico Cooperative Extension Service.

Owens also has served as President of one of the four regional divisions of the American Association for the Advancement of Science, is past Chair of the Board on Agriculture of the National Association of State Universities and Land-Grant Colleges and was named a Distinguished Alumnus by

Texas Tech University. He was commissioned through ROTC and served as a major in the United States Army.

One of the aspects of UNL that attracted Dr. Owens is its Land-Grant mission. He will go into some details of this in his program while describing some of the changes that will have an impact on the future of IANR.

The meeting begins at 11:50 in the City Campus Union.
